Your manuscript entitled "Co-Ownership of Communal Intellectual Property in Perspective Support to Regional Tourism" discusses the intersection of conceptions in Intellectual Property Rights (IPR), especially in placing objects of communal intellectual property using a doctrinal approach by collecting data through literature studies.

In order for this manuscript to be published, there are several problems that need to be resolved. I hope the following recommendations will be useful for writers.

Introduction

As written now, it is difficult to follow the main message of the introduction. The author explains that joint ownership is positioned differently from private ownership which can be placed on objects, both material and immaterial objects, but the concept of Intellectual Property Rights (IPR) in its historical sources prioritizes individual ownership that is just beginning. Therefore, the author must describe the difference between joint ownership and private ownership clearly and clearly. Also explain the gap between expectations and facts in the field.

Methods

This research uses doctrinal legal research methods through a conceptual approach and a statutory approach. It is also necessary to explain the data collection methods and instruments as well as the data analysis used.

Research Results and Discussion

In the results and discussion sections, you write separately, it should be adjusted to the template in this journal.

The article must necessarily be divided into: 1. Introduction (in running text, without subtitles, presenting contextualization, objective or research question and justification), 2. Theoretical Framework, 3. Methodology, 4. Results and Discussion, 5. Conclusion.
